HBV is a non-cytopathic virus, and both control of the virus and the development of immunopathological hepatic lesions are mediated by CD8+T cells. Over a wide dose range (10⁴-10⁸virions), the outcome of infection was similar, being controlled successfully 6-8 weeks after infection with minimal hepatitis.

Immunity and immunopathology to viruses: what decides the ...

The most common mechanism of lesion development in virus induced immunopathology involves T cells. Usually, it seems that when CD8 + T cells act as the controlling cell type, lesions are acute and the outcome is decided quickly. The classic example is provided by LCM in mice. The newest candidate may turn out to be SNV infection in humans.

Immunopathology of Virus-Induced Anterior Uveitis

The absence of a correlation between viral burden and survival rate seen in asthmatic mice suggests that the induced protection was due to suppression of virus-induced immunopathology. This hypothesis was supported by reduced lung injury in asthmatic mice as determined by pulmonary cytokine expression, airway protein levels (indicative of severe edema), and cell death as measured by a cytotoxicity assay.

We now use the murine model of respiratory syncytial virus (RSV) infection to address the impact of sequential infections on immunopathology. In the 1960s, vaccination of infants with formalin-inactivated RSV resulted in a catastrophic enhancement of illness during subsequent natural encounter with this virus, leading to eosinophilic lung infiltrates and excess mortality 12 .

In its most severe forms, dengue virus induces dengue hemorrhagic fever and dengue shock syndrome, both of which are characterized by increased vascular permeability.
